# 1 PRIVACY POLICY

Last updated: February 15th, 2024

This Privacy policy describes our policies and procedures on the collection, use and disclosure of your information when you use the service and tells you about your privacy rights and how the law protects you.

We use your personal data to provide and improve the service. By using the service, you agree to the collection and use of information in accordance with this privacy policy. #### Interpretation and definitions

#### Interpretation

The words of which the initial letter is capitalized have meanings defined under the following conditions. The following definitions shall have the same meaning regardless of whether they appear in singular or in plural.

#### **Definitions**

For the purposes of this privacy policy:

- Account means a unique account created for you to access our service or parts of our service.
- Company (referred to as either "the company", "we", "us" or "our" in this agreement) refers to ACI Conference 2024 mailto: <a href="mailto:info@aci2024.com">info@aci2024.com</a>
- Cookies are small files that are placed on your computer, mobile device or any
  other device by a website, containing the details of your browsing history on that
  website among its many uses.
- Country refers to: Germany
- Device means any device that can access the service such as a computer, a cellphone or a digital tablet.

- Personal Data is any information that relates to an identified or identifiable individual.

- Service Provider means any natural or legal person who processes the data on behalf of the company. #### Types of data collected

#### Personal data

#### **Usage data**

- Cookies or Browser Cookies. A cookie is a small file placed on your device. You
  can instruct your browser to refuse all cookies or to indicate when a cookie is being
  sent. However, if you do not accept cookies, you may not be able to use some parts
  of our service. Unless you have adjusted your browser setting so that it will refuse
  cookies, our service may use cookies.
- Web Beacons. Certain sections of our service and our emails may contain small
  electronic files known as web beacons (also referred to as clear gifs, pixel tags, and
  single-pixel gifs) that permit the company, for example, to count users who have
  visited those pages or opened an email and for other related website statistics (for
  example, recording the popularity of a certain section and verifying system and
  server integrity).

Cookies can be "persistent" or "session" cookies. Persistent cookies remain on your personal computer or mobile device when you go offline, while session cookies are deleted as soon as you close your web browser. We use both, session and persistent cookies for the purposes set out below:

#### Necessary / Essential cookies

- Type: Session Cookies
- Administered by: Us
- Purpose: These Cookies are essential to provide you with services available through the website and to enable you to use some of its features. They help to authenticate users and prevent fraudulent use of user accounts. Without these cookies, the services that you have asked for cannot be provided, and we only use these cookies to provide you with those services.

#### Cookies policy / Notice acceptance cookies

- Type: Persistent cookies
- Administered by: Us
- Purpose: These cookies identify if users have accepted the use of cookies on the website.

#### Functionality cookies

- Type: Persistent cookies
- o Administered by: Us
- Purpose: These cookies allow us to remember choices you make when you use the website, such as remembering your login details or language preference.
   The purpose of these cookies is to provide you with a more personal experience and to avoid you having to re-enter your preferences every time you use the website.

#### Use of your personal data

The Company may use personal data for the following purposes:

- To provide and maintain our service, including to monitor the usage of our service.
- To manage your account: To manage your registration as a user of the service.

We may share your personal information in the following situations:

- **For business transfers:** We may share or transfer your personal information in connection with, or during negotiations of, any merger, sale of company assets, financing, or acquisition of all or a portion of our business to another company.
- With Affiliates: We may share your information with our affiliates, in which case we will require those affiliates to honor this privacy policy. Affiliates include our parent company and any other subsidiaries, joint venture partners or other companies that we control or that are under common control with us.
- **With business partners:** We may share your information with our business partners to offer you certain products, services or promotions.
- With other users: When you share personal information or otherwise interact in the public areas with other users, such information may be viewed by all users and may be publicly distributed outside.
- **With your consent**: We may disclose your personal information for any other purpose with your consent.

#### Retention of your personal data

The company will retain your personal data only for as long as is necessary for the purposes set out in this privacy policy. We will retain and use your personal data to the extent necessary to comply with our legal obligations (for example, if we are required to retain your data to comply with applicable laws), resolve disputes, and enforce our legal agreements and policies.

The company will also retain usage data for internal analysis purposes. Usage data is generally retained for a shorter period of time, except when this data is used to strengthen the security or to improve the functionality of our Service, or we are legally obligated to retain this data for longer time periods.

#### Transfer of your personal data

Your information, including personal data, is processed at the company's operating offices and in any other places where the parties involved in the processing are located. It means that this information may be transfered to — and maintained on — computers located outside of your state, province, country or other governmental jurisdiction where the data protection laws may differ than those from your jurisdiction.

Your consent to this privacy policy followed by your submission of such information represents your agreement to that transfer.

The company will take all steps reasonably necessary to ensure that your data is treated securely and in accordance with this privacy policy and no transfer of your personal data will take place to an organization or a country unless there are adequate controls in place including the security of your data and other personal information.

#### Delete your personal data

You have the right to delete or request that we assist in deleting the personal data that we have collected about you.

Our Service may give you the ability to delete certain information about you from within the service.

You may update, amend, or delete your information at any time by signing in to your account, if you have one, and visiting the account settings section that allows you to manage your personal information. You may also contact us to request access to, correct, or delete any personal information that you have provided to us.
